### **TERMS & CONDITIONS**

1. Buyers are requested to drop their tenders in the tender box at PSC Plant Khanewal which should reach in the office of the undersigned on 09.03.2020 upto 1200 hours. The same will be opened on the same day at 1230 hours in the presence of tender opening Committee and representatives of the firms/buyers.
2. Buyers should carefully read the terms & conditions and these will be implemented by them positively.
3. All auction-able items will be sold '**as is and where is**' basis and can be examined at PSC Plant Khanewal before submitting rates and after that no excuse will be entertained.
4. Buyers are requested to quote their rates wheat kachra & paddy kachra per 40-kg (without jute bag) and for cotton lint bales per maund (**37.324 kg**) and submit their bids for lint bale lot-wise.
5. In case of acceptance of rates the buyers will have to lift lot No. wise lint bales.
6. Earnest money/bid security of 2% of each item price will have to be enclosed in shape of bank draft/pay order (**refundable**) in favor of Punjab Seed Corporation as earnest money for these auction-able items of which price is given alongwith the tender without which no tender will be accepted. Pay order/bank draft enclosed with the unsuccessful tenders will be refunded after finalization of the tender.
7. Unconditional tender must be valid / acceptable for **45 days** from the opening date of the tenders.

8. In case of acceptance of tender an amount equal to 10% (inclusive of 2% earnest money Bid security already furnished) of the total value of the wheat kachra, Paddy kachra and bales shall have to be deposited in the shape of bank draft/pay order as performance guarantee in favor of Punjab Seed Corporation within five days of the issuance of acceptance letter failing which 2% earnest money/bid security will be forfeited in the favor of Punjab Seed Corporation.
9. From the date of security money is received and delivery order is issued, the entire quantity of wheat kachra, paddy kachra & lint bales will have to be lifted within **30 days** on cash & carry basis. Otherwise Punjab Seed Corporation reserves the right to charge **2%** per month as lifting charges of the total amount of the remaining wheat kachra, paddy kachra & lint bales for the delayed days unless the Managing Director/Chairman Purchase and Sale Committee grants extension for the lifting period after knowing such circumstances which were beyond the control of the buyer.
10. Security may be forfeited if the wheat kachra, paddy kachra & lint bales are not lifted within the stipulated time period. Delay in lifting and amount to be paid will have no relevance to the security amount. Separate late lifting charges will be received for the delayed days in every case.
11. In addition to the total tendered value of the wheat kachra, paddy kachra & lint bales **10% for filer & 20% for non filer** advance tax on the gross sale value will be collected U/S 236-A of Income Tax Ordinance 2001. Sales tax, if applicable, will be charged from the buyer (as per sales tax rules). Only registered firms/parties with sale tax department can participated in lint bales auction.
12. Punjab Seed Corporation reserves the right to make increase or decrease by **15%** in the total quantity.
13. Weighment will be made at above mentioned PSC Plant Khanewal. All other expenses such as loading, carriage charges and the insurance amount from the date of acceptance of tendered rate upto the date of upliftment of the consignment, etc shall be born by the purchaser.
14. The Managing Director/Chairman Purchase and Sale Committee reserves the right to accept or reject anyone item or all the tenders. The PSC shall, however, upon request of bidder may communicate reason of rejection without any further liability to giving justification of the matter.
15. During the sale of auction-able items if any dispute arises, the Managing Director/Chairman Sale & Purchase Committee shall appoint an Arbitrator

whose decision in this regard will be final & binding on both the parties and will not be challenged in any court of law or institute.
